

**BOARD OF EDUCATION  
SPECIAL ORGANIZATIONAL MEETING MINUTES  
NOVEMBER 19, 2013**

An organizational meeting of the Enfield Board of Education was held at the Enfield Town Hall in Council Chambers, located at 820 Enfield Street, Enfield, CT on November 19, 2013.

1. **CALL TO ORDER:** The meeting was called to order at 7:00 PM by Mr. Neville.
2. **PLEDGE OF ALLEGIANCE:** Mr. Neville
3. **OATH OF OFFICE FOR THE NEWLY ELECTED BOARD MEMBERS:**

Town Clerk, Mrs. Suzanne Olechnicki administered the Oath of Office for the 2013-15 Board of Education Members – David Bouley, Vincent Grady, Peter Jonaitis, Tina LeBlanc, Timothy Neville, Thomas Sirard, Stacy Thurston, Lori Unghire and David Wawer.

Mrs. Olechnicki congratulated Board members and wished them a successful term as Board of Education Members.

Mr. Neville congratulated all of the Board of Education Members.

4. **ROLL CALL:**

5. **ELECTION OF OFFICERS:**

Mr. Neville opened up the floor for nominations for Chairperson.

**a. Chairperson of the Board of Education**

Mr. Grady nominated Thomas Sirard as the Chairperson for the Enfield Board of Education, seconded by Mrs. Unghire. Mr. Grady read a prepared statement regarding his nomination for Mr. Sirard.

Mr. Bouley nominated Peter Jonaitis as the Chairperson for the Enfield Board of Education, seconded by Mr. Wawer. Mr. Bouley read a prepared statement regarding his nomination for Mr. Jonaitis.

Mr. Neville moved, seconded by Mr. Grady to close the nominations for Chairperson. All ayes, motion passed unanimously.

Mr. Neville called for a roll call vote for the Chairperson for the Enfield Board of Education.

A vote by **roll-call 6-3-0** passed in favor of Mr. Sirard as the 2013-15 Chairperson for the Enfield Board of Education with Mr. Jonaitis, Mr. Wawer and Mr. Bouley in dissent.

Mr. Neville congratulated Mr. Sirard on his appointment as Chairperson for the Enfield Board of Education.

**b. Vice Chairperson of the Board of Education**

Chairman Sirard opened up the floor for nominations for Vice Chairperson.

Mr. Jonaitis nominated David Wawer as the Vice Chairperson for the Enfield Board of Education, seconded by Mr. Grady.

Mr. Grady moved, seconded by Mr. Neville to close the nominations for Vice Chairperson. All ayes, motion passed unanimously.

A vote by **roll-call 9-0-0** passed unanimously for Mr. Wawer as the 2013-15 Vice Chairperson for the Enfield Board of Education.

**c. Secretary of the Board of Education**

Chairman Sirard opened up the floor for nominations for Secretary.

Mrs. LeBlanc nominated Vincent Grady as the Secretary for the Enfield Board of Education, seconded by Mrs. Thurston. Mrs. LeBlanc read a prepared statement regarding her nomination for Mr. Grady.

Mr. Neville moved, seconded by Mr. Thurston to close the nominations for Secretary. All ayes, motion passed unanimously.

A vote by **roll-call 9-0-0** passed unanimously for Mr. Grady as the 2013-15 Secretary for the Enfield Board of Education.

**6. SERVICE RECOGNITION AWARDS TO OUTGOING BOARD MEMBERS:**

Chairman Sirard stated we will now present service recognition awards to the outgoing Board members.

Chairman Sirard, Vice Chairman Wawer and Secretary Grady presented Mrs. Szewczak with a plaque of appreciation from the Board of Education along with her name plate.

Chairman Sirard added that it has been a pleasure and honor working with you and wishes her good luck with her future endeavors.

Mrs. Szewczak thanked everyone for supporting her, listening to her ideas and changing Enfield Public Schools to the 21<sup>st</sup> century. She will miss Mr. Sirard the most. He has sat on her left and on her right for the past few years. He understands what I am thinking and translates it so it makes more sense. Ms. Hall is someone she calls a friend and has worked with for many years. She thanked everyone on the Board.

Chairman Sirard, Vice Chairman Wawer and Secretary Grady presented Mrs. Rancourt with a plaque of appreciation from the Board of Education along with her name plate.

Chairman Sirard stated it has been a distinct privilege to serve with you on the Board of Education. He knows you worked very hard and were very passionate with your beliefs. Chairman Sirard stated that Ms. Hall will be missed. You have a wealth of knowledge about our school system and what is going on at the State level that is incredible. He respects you and called her a friend.

Ms. Hall stated that the Board of Education has a lot to be impressed about like Youth Vote, Technology Advancements, Full Day Kindergarten, AP Honor Roll, First Readers Program and LEGO Education. The new Board's primary goal will be student achievement, whether you are building your budget, reviewing curriculum or recognizing academic achievement. There is a significant learning curve of 2 years for new Board members. There are training programs that will give you the key notes of what you need to know as Board members. She encourages all new Board members to take advantage of these training programs. They will help you when it comes to legal issues and for making good decisions.

Chairman Sirard thanked Mrs. Szewczak, Mrs. Rancourt, Ms. Hall and Mr. Fealy you will all be truly missed. Your service as a Board member will always be remembered.

Chairman Sirard presented Mr. Neville with a director's gavel that he used as the Chairman for the past two years. You did a wonderful job as our chair. You have earned my respect and hopefully I have earned yours. Thank you.

Mr. Neville stated as previously mentioned by Ms. Hall, this is a learning experience. We learn by listening to each other. This Board worked well together and we grew as a Board. We accomplished some of our goals like full day Kindergarten with two different administrations. Working with two different administrations was a task in itself. We accomplished this by working together. He hopes that the new Board will continue to work together. Thank you for working with him and your support. He respects all of the Board members as we have grown in our positions. Thank you.

**7. COMMENTS, IF ANY, FROM THE NEWLY ELECTED CHAIRPERSON:**

Chairman Sirard thanked his wife and his family for their support. Without his wife's support he would not be able to do this. He thanked the voters for their faith and support.
